

General Terms and Conditions

Effective Date: 1 January 2023

I agree with The Academy Xue Yuan (ABN 79 611 736 415) (“the Academy”) that in consideration for the Academy considering my candidature for the Program and the opportunity to potentially appear in or in association with the Program, amongst other things, I hereby consent to the filming and recording of such contribution and my involvement in the Auditions and the Program and the use of my audition materials by the Academy on the terms and conditions below:

Eligibility

1. I am at least 11 years of age on 1 January 2023.
2. I will supply a copy of my birth certificate, passport, driver’s licence, identity card, or other such documentation as the Academy requires to confirm my identity.
3. I understand that if I am younger than 18 years of age on 1 January 2023, that I must have the permission and agreement of my parent/s or legal guardian/s to participate in the Auditions and the Program and my parent/s or legal guardian/s (as the case may be) must agree to these terms and conditions and sign the General Terms and Conditions and the Parental/Legal Guardian Consent and all other releases and waivers and other documents that I am required to sign in respect of my participation in the Auditions and the Program.
4. I acknowledge that the Academy reserves the right to cease to provide the Program to any person who it determines, in their sole discretion, cannot prove their identity or who is later discovered to be not eligible for the Program.
5. I do not have any adverse medical or psychological condition which may hinder my participation in the Program.
6. If I develop an adverse medical or psychological condition which may hinder my participation in the Program, I undertake to provide a letter from a registered medical practitioner (“Health Safety Letter”) confirming that my continued participation will not impede on my safety or the safety of the other participants and trainers. I understand the Academy reserves the right to cancel my participation in the Program in the event I am unable to provide a Health Safety Letter at least 14 days prior to the commencement date or as and when required by the Academy.

7. I understand and agree that the Academy reserves the right to cancel my participation in the Program in the event the Academy deems me to be a safety concern to myself, the other participants, the Academy or its staff, and other third parties connected with the Program.
8. I understand and agree that the Academy may cancel my participation in the Program in the event the Academy, in its sole discretion, takes the view that I am not participating in the Program in good faith and with the spirit of competition.
9. I accept and agree that my application to participate in the Program may be accepted, rejected and/or qualified with further conditions by the Academy in its sole discretion.
10. I understand and accept that it may take several weeks before I hear from the Academy in relation to my application and Audition and acknowledge given the many applicants who apply, that I may only hear from the Academy if I have been invited to participate in the Program.
11. If selected as a participant in the Program, I will execute all documents, waivers and releases required by the Academy and/or its third party contractors.

Fees

12. I agree to pay the relevant fees (“the Fees”) in accordance with the schedule of fees (“the Schedule”) at the relevant times as provided by the Schedule or as amended by the Academy.
13. I acknowledge that the Academy may refuse to consider my application if I do not pay the Fees in accordance with the Schedule.
14. I acknowledge under no circumstance will I be entitled to a refund of the Fees even in circumstances where my participation in the Program is terminated by the Academy.
15. In the event my payment of the Fees is dishonoured, I agree to pay to the Academy, the appropriate Fees plus an administration cost of AUD\$55.00 in consideration of the additional time spent processing my application.

The Audition and the Program

16. The Academy provides participants with the chance of participating in a ‘boot camp’ with other participants and certain trainers and mentors who will provide group coaching to the participants in relation to dance and other entertainment skills (“the

18. Program”). The Program will provide participants an experience of how entertainers are trained in the Republic of Korea.
19. The Academy will publish the dates and venues of where it intends to conduct and record auditions of participants at various locations across Australia and internationally (“the Auditions”). At some time after the Auditions, the Academy and/or its staff, trainers and mentors will invite 102 participants (“the Invitees”), decided at the Academy’s sole discretion, to participate in the Program.
20. The Academy will extend to the Invitees an invitation to participate in the Program. In the event any Invitee does not accept the invitation within the prescribed time as indicated on the invitation, the invitation will automatically expire, and the Academy will invite another suitable participant. The invitation must be accepted in accordance with the directions provided by the invitation.
21. Only those participants who accept the invitation and in all other respects comply with the terms and conditions provided by the Academy may participate in the Program.
22. Generally, and by no way prescriptive, those participants who participate in the Program will be split between two groups, one which is recorded and one which may not be recorded. The Academy and/or its staff, trainers and mentors, decided at the Academy’s sole discretion, will decide who participates in each group.
23. I understand that the dates marked for the Auditions and for the production of the Program may change from time to time and in the event I am unable to attend production of the Program on the amended date, I will forfeit my right to participate. I acknowledge I will not be refunded in this circumstance.
24. If I am invited to participate in the Program and I accept the invitation (“my Acceptance”), I represent and warrant that I will be available for the production of the Program in accordance with the Schedule or as amended from time to time, and confirm that I will be available for any necessary medical and psychological examinations prior to or during that period as arranged by the Academy in consultation with me, and I am willing to travel to various locations as part of the Program.
25. I will pay for all expenses related to my participation in the Auditions and the Program and I acknowledge my Acceptance indicates that I am willing to pay for all expenses related to my participation in the Program including travel to, from and within South Korea, accommodation in South Korea (other than standard accommodation provided as part of Program costs), all living expenses including food for the duration of the Program (other than standard meals provided as part of Program costs), and both before and after the Program dates, and the cost of any medical treatment received with respect to my participation.

26. I am willing to submit medical information to the Academy and to undertake a medical and psychological examination, and background and police checks if requested by the Academy.
27. I will abide by the rules of the Auditions and the Program as advised from time to time, and the reasonable direction of the Academy and its staff and the trainers.
28. I understand that the training methods engaged by the trainers of the Academy are secret and proprietary and I cannot make any claim in relation to the type, method or delivery of the training.

General

29. Headings are for convenience only and do not affect the interpretation of this agreement.
30. I understand that I am submitting an Application to be considered for my participation in the Auditions and the Program and acknowledge my details, personal and otherwise, will be included in a database for this purpose.
31. I hereby warrant, represent, acknowledge and agree that:
 - a. I have read, met and agree to be bound by the General Terms and Conditions and eligibility requirements;
 - b. I have completed my application associated with the Program accurately and honestly, and agree that all answers and information supplied in the application will be in no way misleading. I expressly acknowledge the Academy may disqualify me from the Program without refund of any Fees paid by me, should I at any stage supply misleading, or dishonest personal details or information, break the rules, or put the safety of the staff of the Academy or other participants at risk;
 - c. The Academy has no obligation to interview me or to select me as a participant in the Program;
 - d. Even if I am selected as a participant, the Academy has no obligation to record me, or broadcast my involvement in the Program;
 - e. All decisions made by the Academy is final and is not subject to challenge or appeal; and
 - f. No material provided to the Academy by me or on my behalf will be returned to me.

- at I will not be paid any money for releasing the Academy and the Releasees pursuant to these terms and conditions. I agree that I will not be paid any money for conferring the rights to the Academy and the Releasees referred to in these terms and conditions. I agree that in consideration of the aforementioned grants and releases, the Academy at its labour and expense, has provided me the potential opportunity to participate, and potentially appear in or in association with the Program (“the Benefits”). I expressly agree that the Benefits include sufficient and adequate consideration for the use and exploitation of my contributions to the Program, the Likeness and the Works by any means and media, anywhere in the universe and I waive any right and/or entitlement to any equitable relief, compensation, remuneration, or other payment howsoever arising. I further acknowledge and agree that the Benefits also include full and final consideration for my attendance at any and all activities as required by the Academy in connection with the Program. I also acknowledge that no Fee will be payable to me in respect of any subsequent rebroadcast or retransmission or any other use by the Academy or the Releasees (or any assignees or licensees) of the Program or any part thereof.
33. I acknowledge that I am responsible for my own personal wellbeing and will not hold the Academy, its staff or the trainers responsible for:
- a. Any injury or illness suffered during the course of the Program;
 - b. Any injury, illness, or aggravation of pre-existing or previous injuries or conditions sustained by you during the course of the Program; and
 - c. Any damage to or loss of your personal property during the Program.
34. I acknowledge that I will not be entitled to a refund of the Fee under any circumstance.
35. I will at the request of the Academy, do everything necessary, including execute any documents, to give effect to these terms and conditions and the transactions contemplated by it and cause third parties to do the same.
36. If the whole or any part of a provision of the General Terms and Conditions is void, unenforceable or illegal in a jurisdiction, it is severed for that jurisdiction. The remainder of the General Terms and Conditions has full force and effect and the validity or enforceability of that provision in any other jurisdiction is not affected. This clause has no effect if the severance alters the basic nature of the General Terms and Conditions or is contrary to public policy.
37. I agree and acknowledge that my sole remedy for any breach of these terms and conditions is an action at law for damages (if any), capped at the maximum value of the Fees I have paid to the Academy, and that I do not have the right to rescind these terms

ditions or to revoke any rights granted under these terms and conditions. This term is an essential condition of these terms and conditions.

Grants of Rights

39. In submitting this application:

- a. I consent to the recording, use, and reuse by the Academy and any of its respective licensees, and assignees, and each of their respective employees, agents, representatives, officers and directors (“the Releasees”) of my voice, actions, likeness, name, appearance, biographical material, and any information contained in, derived from or obtained in connection with my application (collectively “Likeness”) and, if successful, my participation in the Program. This information includes any personal information as defined in the Privacy Act 1988 (Cth) or otherwise as edited, altered, or modified by the Academy or by the Releasees, in any form of media, throughout the universe in perpetuity, in or in connection with the Program.
- b. I agree that the Academy exclusively owns all rights, title and interest in and to any and all intellectual property made by the Academy, the Releasees for or for the purpose of the Program and any other materials that I have provided or may provide in connection with my application or the Program (“the Materials”).
- c. I authorise the Academy and the Releasees to modify, alter or edit the Materials and to use all or part of the Materials and my Likeness in any and all media in perpetuity.
- d. I grant an irrevocable, royalty free licence in any and all media now known or hereafter devised, throughout the universe in perpetuity to the Materials and any music and/or video solely for the purpose of the Program.
- e. Without limiting the previous paragraph, I irrevocably assign the entire copyright, other intellectual property rights and all other rights of whatsoever nature in my contribution to the Program, the Likeness and the Materials (“the Works”) such that the Academy shall be entitled to use and exploit and license others to use and exploit my contributions to the Works by all means and in all media for the full period of copyright including any extensions and renewals as is possible in perpetuity. Further, I irrevocably grant all consents and waivers (to the extent permissible by law) necessary to enable the Academy to make fullest use of the Works without restriction.

acknowledge the needs of media production, promotion and distribution and without limiting these terms and conditions, irrevocably consent to the Releasees editing, producing, promoting and adapting the Works or any other act or omission in relation to the Works as the Releasees deem fit in their absolute discretion. I acknowledge and agree that the Releasees will not be liable to me and that I will have no claim against the Releasees or any other person for any act or omission of the Releasees resulting in any prejudicial or derogatory portrayal or representation of me and/or the Works.

40. I irrevocably agree and authorise the Releasees to:
- a. Alter, adapt or make additions to or deletions from the Program (and the Works) at their discretion;
 - b. Make and exploit and to authorise the making and exploitation of any recording or fixation of my Likeness separately from or in conjunction with the Program throughout the Universe in perpetuity in all media;
 - c. Dub my voice in any language;
 - d. Interpret my speech in any language including sign language;
 - e. Use my Likeness, the Works, photographs of me and recordings of interviews with me in conjunction with the Program in all media throughout the universe including but not limited to advertising, publicity, promotions, marketing and exploitation material; and
 - f. Transfer Personal Information about me overseas to related body corporates and third parties associated with the Program and to use the Personal Information in accordance with these terms and conditions and the Privacy Policy.

Intellectual Property Release

41. In the event I do participate in the Auditions and, if I am successful, the Program itself, I agree to sign any separate agreement with the Academy to the effect that in consideration of my participation in the Program, the Academy will own all of the rights in the Program including any audition materials (electronic or otherwise) submitted with my application and I agree that the Academy may freely broadcast and make available for all other media and other purposes, without restriction and without any payment to me.

42. In submitting this application:

- a. I release the Releasees (jointly and severally) from any and all liability arising out of the recording and production of my Likeness and the Materials (including, without limitation to any claim that alleges defamation, or invades any right of privacy and/or publicity).
- b. I agree to irrevocably release the Releasees from any act or omission constituting an infringement of my moral rights as that term is understood pursuant to any law or regulation now, or in the future (“Moral Rights”). I irrevocably waive to the extent allowed by law and agree never to assert any Moral Rights arising out of or in connection with the Works against the Releasees or any other person throughout the universe in perpetuity.
- c. I acknowledge and agree that my Moral Rights or any other rights are not infringed in the event the Works are modified, altered, edited, produced, distributed, broadcasted or adapted for the Program.

43. The Releasees (jointly and severally) shall not be liable to me or my legal representative for any loss, damage, or injury to me or my property caused by or suffered during or in connection with my taking part in the Program unless caused by the negligence of a Releasee and recoverable on that ground from that Releasee following judgment of a competent court of final judgment.

Confidentiality

44. I agree not to disclose to any third party (other than my professional advisors) any information relating to the Program or the affairs of the Academy, which may come to my knowledge during or in connection with my participation in the Program.
45. I agree that I will not publicise or discuss with any third party without the prior written consent from the Academy, any information relating to the Program, my appearance in the Program, any participants in the Program or any other information which may come to my attention relating to the Academy, or otherwise connected to the Program, except such information which is already public knowledge. Should I be contacted by a member of the press or talent scouting agency at any time, I agree to refer them to the Academy or such other person as the Academy may nominate.
46. I agree to be bound by the General Terms and Conditions, now and whensoever updated, whether or not I am selected to participate in the Program in any manner whatsoever.

Terms and Conditions of the Program

47. I understand that in the event the Academy is unable to achieve the required number of participants or achieve certain targets, the Academy may at its sole discretion cancel the auditions, the Program, or any part of either.
48. I understand the Academy otherwise reserves its rights under the General Terms and Conditions and for the avoidance of doubt, the Academy reserves its sole discretion to refund any Fees.

Privacy

49. I agree and acknowledge that the Academy deals with the collection, security, use and disclosure of personal information in accordance with its Privacy Policy and the Privacy Act 1988 (Cth) and I hereby authorise the Academy to investigate, access, and collect information about me, about any of the statements made by me in my application, any supporting documents and other documents that I have signed or provided to the Academy, or in any other communication (whether written or oral) to the Academy.
50. I irrevocably authorise the Academy to disclose information concerning me to government agencies, medical providers, employers and other organisations or providers relevant to the Program or as required under any relevant law or regulation.
51. I authorise and consent to the use of my Personal Information (which may include “sensitive information” as defined in the Privacy Act 1988 (Cth)) given to the Academy or collected by the Academy in determining my suitability for the Program and to communicate such information to third parties, including but not limited to the general public through internet streaming, television broadcasts or other media distribution and I agree that there will be no restrictions on the use of Personal Information relating to me that is contained in the recording of the Program.
52. You have the right to request access to Personal Information held by the Academy that relates to you. If the Personal Information held by the Academy is inaccurate you have the right to request it to be updated.
53. I hereby authorise an appropriately qualified person or entity as designated by the Academy to conduct psychological and physical examinations of me as required by the Academy and authorise the individual conducting the examination to disclose to the Academy and their representative all information about me obtained in connection with such examinations, and authorise the Academy to use this information in selecting participants for the Program.
